Transit schedule adjustments begin Aug. 14

Chapel Hill Transit is adding more service as part of its August service schedule adjustments to meet ridership demands, increase reliability and improve connections to employment and retail centers. These changes will take effect on Monday, Aug. 14.

The CW route will add more trips between 7:40 and 9:20 a.m. The NS route will have extended evening trips (8:20–10:50 p.m.) to serve Southern Village Park and Ride and increase frequency to Eubanks Park and Ride.

A new Saturday V Route will be added to serve Meadowmont, downtown, UNC Hospitals and Southern Village from 8:45 a.m. to 5:14 p.m.
